16		2. The duration of this grant shall be from December 1, 2006 and remain in effect for					
17		a twelve-month period through November 30, 2007.

19	Nation Official, to wit: the Chairwoman and any designated official are authorized to						
20		negotiate and execute the grant, provided however, that any amendments affecting
