2		has identified cancer prevention, early detection and treatment as an emerging is sue
3		for the Tohono O'odham Nation; and
4	WHEREAS,	TODHHS has designed a one-year project to build capacity to address cancer as a
5		chronic disease; and
6	WHEREAS,	TODHHS has been awarded a grant by the Arizona Department of Health Services in
7		the amount of \$7,426.50, which does not allow the inclusion of indirect costs; and
8	WHEREAS,	the Arizona Department of Health Services and the Nation have negotiated an
9		Intergovernmental Agreement to provide the funds for this project, which
10		intergovernmental agreement includes provisions to preserve the sovereign
11		immunity  from  suit  of  the  Tohono  O'odham  Nation  and  to  restrict  the  application  of  constant  and  constant  application  of  constant  application
12		state law on the Nation's government; and
13	WHEREAS,	the Health and Human Services Oversight Committee and the Budget and Finance
14		Committee have reviewed the Intergovernmental Agreement and recommend
15		approval by the Legislative Council.
16	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
17		1. Approves the Intergovernmental Agreement with the Arizona Department of
18		Health  Services  for  the  Tohono  O'odham  Cancer  Awareness  Project  substantially  and  continuous  and  continuous  are the extension of
19		in the form attached hereto, and authorizes the Chairwoman of the Nation to
20		execute the document and any related documents and amendments for
21		extension of time necessary to receive and expend the \$7,426.50 for the project.
22		2. Requires that any amendments which change the amount of the grant will be
23		brought to the Legislative Council for approval.
24		3. Waives any requirement to be paid for indirect costs for this project.
25		4. Authorizes the program to expend the funds.
26	BE IT FINAL	LY RESOLVED THAT THE Tohono O'odham Legislative Council hereby authorizes the
27		Chairwoman and any designated official to expend and administer the budget
28		attached, provided that any amendments affecting the funds or funding level shall
29		be  submitted  for  further  prior  approval  by  the  Tohono  O'odham  Legislative  Council.
