

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation Vocational Rehabilitation Program
FY 2007 Budget Amendment I, Grant Award # H250D030012)

RESOLUTION NO. 07-266

1 **WHEREAS, the Tohono O'odham Legislative Council has previously supported the Nation's**
2 **Education Department in submitting a grant proposal that established the Vocational**
3 **Rehabilitation Program under Resolution No. 03-149; and**

4 **WHEREAS, the Tohono O'odham Nation was awarded a grant under the U.S. Department of**
5 **Education Office of Special Education Rehabilitation Services/Rehabilitation Services**
6 **Administration's Section 121 (Vocational Rehabilitation Services Projects for**
7 **American Indians with Disabilities) of the Rehabilitation Act and received grant**
8 **notification number H250D030012; and**

9 **WHEREAS, services will be provided to eligible enrolled Tohono O'odham members with**
10 **disabilities living on or near the Nation, and other federally recognized American**
11 **Indians with disabilities living on the Nation; and**

12 **WHEREAS, the services provided will be consistent with individual strengths, resources,**
13 **priorities, concerns, abilities, capabilities, and informed choice so that they may**
14 **prepare for and engage in gainful employment; and**

15 **WHEREAS, a carryover amount has been identified from fiscal year 2006, and is included into the**
16 **current program budget of \$400,000.00, which will increase the budget to \$527,252.26.**
17 **And the Administrative Assistant Position underwent reclassification and is now an**
18 **Administrative Secretary thereby decreasing the 610 Salaries and 620 Fringe Benefits**
19 **line items by \$4,026.20; and**

20 **WHEREAS, the Human Resource Development and Budget & Finance Committees have reviewed**
21 **FY 2007 Vocational Rehabilitation Program Budget Amendment I, which is hereby**
22 **incorporated by this reference, and recommends approval.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
24 **approves the Vocational Rehabilitation Program's FY 2007 Budget Amendment I,**
25 **identifying the Administrative Assistant Position reclassification and is now an**
26 **Administrative Secretary thereby decreasing the 610 Salaries and 620 Fringe Benefits**
27 **line items by \$4,026.20, creating new line item 750 Major Capitol and reflecting**
28 **carryover funds from FY06, which will be added to the current program budget of**

1 \$400,000.00 for a grand total of \$527,252.26 and will revert back to the annual base
2 budget.

3 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
4 **Nation's Official, to wit: the Chairwoman is authorized to execute and expend the grant**
5 **award to September 30, 2007, and provide continued culturally appropriate**
6 **vocational rehabilitation services to its eligible clients, provided however, that any**
7 **amendments affecting the funding level of this grant shall be submitted for further**
8 **approval by the Tohono O'odham Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
10 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,344.25 FOR; -0- AGAINST;**
11 **96.55 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)**
12 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
13 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
14 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


