

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services
2007 Community Health Assessment)

RESOLUTION NO. 07-267

- 1 **WHEREAS, the Department of Health and Human Services is responsible for promoting and**
2 **protecting the health of the Nation's members; and**
- 3 **WHEREAS, the Department of Health and Human Services conducted a Community Health**
4 **Assessment in 2002 to assess and establish a baseline regarding the health status of**
5 **adult tribal members; and**
- 6 **WHEREAS, the information collected from the 2002 Community Health Assessment has been used**
7 **in a confidential and internal manner for health planning and program development**
8 **purposes, including securing grants funds for ongoing and new program services; and**
- 9 **WHEREAS, the Department of Health and Human Services proposes to conduct a follow-up**
10 **assessment of health status, known as the 2007 Community Health Assessment, to**
11 **assess health status, identify health trends and measure change over the past five-year**
12 **period; and**
- 13 **WHEREAS, the 2007 Community Health Assessment is designed to provide information on the**
14 **following health issues among adult tribal members who reside on the reservation;**

 - 16 • **Veteran's Status**
 - 17 • **Health Status**
 - 18 • **Health-Related Quality of Life**
 - 19 • **Health Care Access and Utilization**
 - 20 • **Environmental Factors**
 - 21 • **Exercise and Nutrition**
 - 22 • **Excess Sun Exposure**
 - 23 • **Tobacco Use**
 - 24 • **Alcohol Consumption and Drug Use**
 - 25 • **Asthma**
 - 26 • **Diabetes**

 - 30 • **Arthritis Burden**
 - 31 • **Cardiovascular Disease**

5 **WHEREAS, the 2007 Community Health Assessment will be managed by the Department of Health**
6 **and Human Services to ensure that all information collected from a random sample**
7 **of adult tribal members by trained employees will be maintained confidential; and**

8 **WHEREAS, questionnaires will be destroyed once data is entered into the database, all aggregate**
9 **data will be anonymous and all data will be stored in a locked file cabinet; and**

10 **WHEREAS, the data collected by the 2007 Community Health Assessment will be the confidential,**
11 **intellectual property of the Nation for the purpose of planning, development and**
12 **evaluation by the Department of Health and Human Services.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **approves:**

- 15 1. **The Tohono O'odham Department of Health and Human Services to conduct the**
16 **2007 Community Health Assessment.**
- 17 2. **All information collected will not be released in any form without an approved**
18 **resolution.**
- 19 3. **All confidential data will be maintained by TODHHS (the Nation's Public Health**
20 **Authority).**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairperson and**
22 **any designated official are hereby authorized to negotiate and execute the 2007**
23 **Community Health Assessment provided, however, that any amendment affecting the**
24 **understanding shall be submitted for further approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
27 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,134.7 FOR; -0- AGAINST;**
28 **306.1 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (c)(2)**
29 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
30 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
31 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
