10	WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Counci
11	of a Conflict Attorney Contract with Lawrence O. Boswell on such terms.

13	1. The Tohono O'odham Legislative Council ratifies and approves the Conflict
14	Attorney Contract for Lawrence O. Boswell in the form attached hereto for the
