5	clients with conflicts of interest who cannot be represented by the Nation's Advocate
6	Program; and
7	WHEREAS, the Advocate Program has presented a contract for John M. Neis which confirms and
8	ratifies the terms and conditions related to his services, a copy of which is attached
9	hereto; and
10	WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council
11	of a Conflict Attorney Contract with John M. Neis on such terms.
12	NOW, THEREFORE, BE IT RESOLVED THAT:
13	1. The Tohono O'odham Legislative Council ratifies and approves the Conflict
14	Attorney Contract for John M. Neis in the form attached hereto for the period of
15	October 1, 2006 through September 30, 2007 in an amount not to exceed \$35,000.00

18	the operating budget of the Advocate Program for fiscal year 2007.
