

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2007 Conflict Attorney Contract for Michelle K. Don Carlos)**

**RESOLUTION NO. 07-282**

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**  
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**  
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to retain Michelle K. Don Carlos to be appointed to**  
5 **represent clients with conflicts of interest who cannot be represented by the Nation's**  
6 **Advocate Program; and**

7 **WHEREAS, the Advocate Program has presented a contract for Michelle K. Don Carlos which**  
8 **confirms and ratifies the terms and conditions related to his services, a copy of which**  
9 **is attached hereto; and**

10 **WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council**  
11 **of a Conflict Attorney Contract with Michelle K. Don Carlos on such terms.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 13 **1. The Tohono O'odham Legislative Council ratifies and approves the Conflict**  
14 **Attorney Contract for Michelle K. Don Carlos in the form attached hereto for the**  
15 **period of October 1, 2006 through September 30, 2007 in an amount not to exceed**  
16 **\$35,000.00 total.**
- 17 **2. Funding for the Conflict Attorney Contract for Michelle K. Don Carlos shall be**  
18 **provided under the operating budget of the Advocate Program for fiscal year 2007.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
21 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,254.1 FOR; 0 AGAINST;**  
22 **186.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 2 (a)**  
23 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


