**(Approving 2007 Budget Modification/Amendment #1 for Coldfields Community,**  
**correcting line item & utilizing 2005 carryover monies)**

**RESOLUTION NO. 07-283**

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on January**  
 2 **6, 2007, of which a quorum was present; and**

3 **WHEREAS, the Coldfields Community Representatives presented a 2007 budget**  
 4 **modification/amendment #1, to correct current line item 819.32 and to utilize 2005**  
 5 **carryover monies in the amount of \$67,134.11; and**

6 **WHEREAS, the modification is to correct the following line item:**

14 **for a total amount of \$67,134.11, increasing Coldfields 2007 original budget of**  
 15 **\$109,469.09 to \$176,603.20; and**

16 **WHEREAS, after review, the Baboquivari District Council has approved Coldfields budget**  
 17 **modification/amendment #1, correcting line item 819.32-Professional Services to**  
 18 **810.32-Professional Services and increasing their original 2007 budget of \$109,469.09**  
 19 **by utilizing 2005 carryover monies in the amount of \$67,134.11, for a total budget**  
 20 **amount of \$176,603.20; and**

21 **WHEREAS, this modification/amendment #1 will deplete Coldfields 2005 carryover monies.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
 23 **Coldfields budget modification/amendment #1, correcting line item 819.32-**  
 24 **Professional Services to 810.32-Professional Services and utilizing 2005 carryover**  
 25 **monies in the amount of \$67,134.11, amending the above mentioned line items, which**  
 26 **increases their original 2007 budget of \$109,469.09 to \$176,603.20.**

27 **BE IT FINALLY RESOLVED that any changes in the justifications, additions and/or the transfer of**  
 28 **funds between line items are to be reviewed and approved by the Budget & Finance**  
 29 **Committee and the Tohono O'odham Legislative Council.**

7 Stat. 984).


