

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Delegating Authority to Deal With Safeguarding the Nation's Accounts)**

RESOLUTION NO. 07-292

1 WHEREAS, concerns have arisen regarding the security of the Tohono O'odham Nation's bank
2 accounts; and

3 WHEREAS, the Interim Treasurer and the Budget and Finance Committee have presented these
4 concerns to the Legislative Council and have presented possible options to take to
5 increase the security of the Nation's accounts; and

6 WHEREAS, the best interests of the Nation will be served by establishing a small group of officials
7 of the Nation which can reach decisions on a day by day basis to establish safeguards
8 to protect the Nation's accounts, including during times when the Legislative Council
9 is not in session.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints the
11 individuals filling the following positions to serve as a decision making team to
12 implement decisions regarding the Nation's bank accounts to increase the security of
13 these accounts:

- 14 1. Chairperson of the Nation
- 15 2. Treasurer of the Tohono O'odham Nation
- 16 3. Budget and Finance Committee
- 17 4. Acting Attorney General.

18 BE IT FINALLY RESOLVED that this team shall exercise these responsibilities and powers until July
19 31, 2007, unless this delegation of authority is further extended by the Legislative
20 Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH. Day
22 of MAY, 2007 at a meeting at which a quorum was present with a vote of 1,205.6 FOR; 993.55
23 AGAINST; 241.65 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
24 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
25 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
27 18, 1934 (48 Stat. 984).




