

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No.1 to add line items 630 INSURANCE and 771 RM VEHICLES
to the FY2007 Rodeo and Fair Committee budget 01-2005)

RESOLUTION NO. 07-297

1 WHEREAS, the Tohono O'odham Legislative Council approved the FY2007 Rodeo and Fair
2 Committee budget 01-2005 with Resolution 06-210, in the amount of \$198,487.00; and

3 WHEREAS, the Rodeo and Fair Committee is requesting that line items 630 INSURANCE and 771
4 RM VEHICLES be added to the FY2007 Rodeo and Fair budget; and

5 WHEREAS, the FY2007 Rodeo and Fair Committee budget 01-2005 has been reviewed by the
6 Tohono O'odham Legislative Commerce Committee and Budget and Finance
7 Committee.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
9 approves the addition of the line items 630 INSURANCE and 771 RM VEHICLES to the
10 Rodeo and Fair Committee budget 01-2005, in accordance with the budget attached
11 hereto.

12 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
13 Chairperson and any designated official to expend and administer the budget, as
14 attached, provided that any amendments affecting the funds or funding levels of the
15 budget shall be submitted for further prior approval by the Tohono O'odham
16 Legislative Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day
18 of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;
19 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1
20 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
21 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).


