

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Amendment of the Grant Award for the USEPA General Assistance
Program (GAP) IV Amendment #1)

RESOLUTION NO. 07-298

1 **WHEREAS, Tohono O'odham Legislative Council accepted \$328,810.14 in new funding for the**
2 **continuation of the General Assistance Program (GAP) on March 21, 2006 by Resolution**
3 **No. 06-183; and**

4 **WHEREAS, the General Assistance Program extends from August 1, 2006 through September 30,**
5 **2009; and**

6 **WHEREAS, on August 24, 2006 the USEPA Region 9 allocated \$280,000.00 for the General Assistance**
7 **Program IV; and**

8 **WHEREAS, there is a difference in the original amount of \$328,810.14 less \$48,810.14; and**

9 **WHEREAS, the program has made adjustments to the line items to reflect the difference, by**
10 **making the appropriate adjustments to the current line items and adding one new**
11 **line item: 722 Program Supplies.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
13 **the budget amendment of \$328,810.14 reduced in the amount of \$48,810.14 for a total**
14 **of \$280,000.00 in the following manner:**

- 15 **1. Decreasing the FY 2007 budget (\$48,810.14).**
- 16 **2. Adding Line item 722 Program Supplies \$1,600.00.**
- 17 **3. Decreasing Indirect Cost as a result of decrease to allocation (\$5,283.52).**
- 18 **4. Authorizing TON EPA to expend all available funds awarded pursuant to**
19 **Cooperative Agreement GA-96981601-0.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that Tohono O'odham**
21 **Nation's Officials, to wit: the Chairperson and any designated official are hereby**
22 **authorized to negotiate and execute the grant, provided however, that any**
23 **amendments affecting the funding or funding level of the grant shall be submitted for**
24 **further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
26 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
28 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




