**8 Budget Amendment #1 has been prepared to incorporate the 19.35% Indirect Cost**  
**9 rate; and**

**10 WHEREAS, the attached FY 2007 Adult Care Services Budget Amendment #1 was also prepared to**  
**11 decrease the funds utilized in the Public Relations line item in order to increase what**  
**12 is utilized in the Office Supplies line item.**

**20 BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairperson and**  
**21 any designated official are hereby authorized to negotiate, expend and execute funds,**  
**22 provided however, that any amendments affecting the funds or funding levels shall be**  
**23 submitted for further prior approval.**

**24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
**25 of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
**26 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
**27 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
**28 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
**29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
**30 Stat. 984).**
