

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Tribal Employment Rights Office FY - 2007 Budget
Modification/Amendment No. 1)

RESOLUTION NO. 07-309

1 WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since
2 1978 in order to increase employment of Indians and to eradicate employment
3 discrimination on and near the Tohono O'odham Nation; and

4 WHEREAS, the Tohono O'odham Nation Executive Branch Personnel Policy Manual requires
5 "Employees assigned to work in a higher classification for more than thirty (30) days
6 will be paid at the corresponding pay rate for work in that class."; and

7 WHEREAS, Christy Bautista, Administrative Assistant was detailed to Acting TERO
8 Director/Administrator on February 12, 2007 to April 30, 2007 during the absence of
9 the TERO Director/Administrator; and

10 WHEREAS, \$1,966.00 is needed to cover the salary cost and \$609.46 is needed to cover the fringe
11 benefit cost owed to Christy Bautista; and

12 WHEREAS, said cost will be taken from Tuition & Registration and Travel Expenses of the tribal
13 budget 01-1070.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it
15 hereby approves the Tohono O'odham Tribal Employment Rights Office FY - 2007
16 Budget Modification/Amendment No. 1.

17 BE IT FINALLY RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono
18 O'odham Nation's officials, to wit: the Chairperson is authorized to implement Tohono
19 O'odham Tribal Employment Rights Office FY - 2007 Budget Modification/Amendment
20 No. 1, provided however, that any amendments affecting the funding, or funding levels
21 of the budget shall be submitted for further prior approval by the Legislative Council.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day
23 of MAY, 2007 at a meeting at which a quorum was present with a vote of 1,591.5 FOR; -0- AGAINST;
24 655.5 NOT VOTING; and 193.8 [08] ABSENT, pursuant to the powers vested in the Council by Section
25 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).


