

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Pia Oik Community Amendment #1 Fiscal Year 2007 of the Gu-Vo District)**

**RESOLUTION NO. 07-311**

1 **WHEREAS, the Gu-Vo District did bring forth the Pia Oik Communities Amendment No. 1 for the**  
2 **Fiscal Year 2007 budget; and**

3 **WHEREAS, the Pia Oik Community is requesting a New Line Item to be added to their FY 07 Budget**  
4 **to assist their elder in their community; and**

5 **WHEREAS, the proposed amendment from the community has gone through proper reviews from**  
6 **the Gu-Vo District and the Tohono O'odham Legislative Budget and Finance**  
7 **Committee; and**

8 **WHEREAS, it is the recommendation of the Budget & Finance Committee to approve Amendment**  
9 **#1 for Pia Oik Community.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
11 **hereby approves the Budget Amendment #1 for Pia Oik Community and by adding a**  
12 **New Line Item and adjusting the amount in the justification of line item 727, in their**  
13 **FY'07 Budget. (See attachment for the new line item and justification).**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>, Day**  
15 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
16 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1**  
17 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
20 **Stat. 984).**


