1 **WHEREAS, the Hickiwan District Council presented its FY 07 Budget Modification/Amendment**  
2 **No. 2 for the Hickiwan District Administration; and**

3 **WHEREAS, the Hickiwan District Council included the Final Gaming Distribution amount of**  
4 **\$7,260.76 in its FY 07 Budget Modification/Amendment No. 2; and**

5 **WHEREAS, the Hickiwan District Council by Resolution No. HDA-07-038 approves the FY 07**  
6 **Budget Modification/Amendment with the inclusion of the Final Gaming Distribution**  
7 **amount of \$7,260.76 increasing the FY 07 Budget to \$854,113.28.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
9 **approves and accepts the inclusion of the Final Gaming Distribution in the amount**  
10 **of \$7,260.76 to the Hickiwan District Council's FY 07 Budget Modification/Amendment**  
11 **to the Hickiwan District Administration increasing the FY 07 Budget to \$854,113.28.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
13 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
14 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**  
15 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
16 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
17 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


