7		employee Fringe Benefits such as Medical Benefits, Dental Benefits, Life Insurance;

9	WHEREAS,	the Tohono O'odham Nation has authorized the Gu Vo District to utilize fuel services
10		from Motor Pool for fuel; and
11	WHEREAS,	the Tohono O'odham Nation has expended funds on behalf of Gu Vo District for
12		vehicle, building and content insurance; and
13	WHEREAS,	the Gu Vo District has requested an Invoice from the Tohono O'odham Nation for
14		prior years unpaid debt (1995 to 2006); and
15	WHEREAS,	the Gu Vo Districts agrees with the prior years debt (1995 to 2006) of \$1,273,971.63;

17	WHEREAS,	the Gu Vo District Council and the Tohono O'odham Legislative Budget and Finance
18		Committee have reviewed and authorized the \$1,273,971.63 payment of Gu Vo
19		District prior years debt (1995 to 2006) to the Tohono O'odham Nation.
20	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
21		authorizes payment of \$1,273,971.63 from the Gu Vo District Money Market Account
22		to the Tohono O'odham Nation General Fund.
23	BE IT FINAL	LY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
24		Office of the Treasurer to initiate, and authorizes the Chairperson of the Nation to
25		complete the transfer of \$1,273,971.63 from the GuVo District Money Market account
26		to the Tohono O'odham Nation General Fund provided however any change or
27		${\bf amendment in this request affecting the transfer shall be submitted for further prior }$
28		approval of the Tohono O'odham Legislative Council.
