

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Apportionment of District Votes on the Tohono O'odham Legislative Council)**

LEGISLATIVE ORDER NO. 07-318

1 **WHEREAS, Article V, Section 2 of the Constitution of the Tohono O'odham Nation provides that**
2 **votes cast by Legislative Council representatives shall be apportioned as follows:**

3 **Each district shall be entitled to as many votes on the Tohono O'odham**
4 **Council (divided by ten) as there are members of the Tohono O'odham**
5 **Nation residing in the district. Such votes may be cast by either or both**
6 **of the district representatives, or their alternates, who are present and**
7 **voting.**

9 **WHEREAS, on Saturday, May 26, 2007 the Tohono O'odham Election Board conducted a general**
10 **election for the offices of chairperson of the Nation, vice-chairperson of the Nation,**
11 **and representatives and alternates to the Tohono O'odham Legislative Council and**
12 **district councils; and**

13 **WHEREAS, on May 27, 2007 the Election Board issued and posted its Certificate of Election Results**
14 **in accordance with Section 6(K) of Article VII of the Uniform Election Ordinance,**
15 **Ordinance No. 03-86; and**

16 **WHEREAS, pursuant to Section 1(B) of Article VII of the Uniform Election Ordinance, the Election**
17 **Board certified and posted its Certificate of District Residents dated May 26, 2007,**
18 **which is incorporated by this reference, apportioning the number of votes each**
19 **district is entitled to cast on the Tohono O'odham Legislative Council; and**

20 **WHEREAS, the number of Legislative Council votes apportioned and certified by the Election**
21 **Board in its Certificate of District Residents totals 2,534.5; and**

22 **WHEREAS, the five-day period for appealing the number of votes given to each district by the**
23 **Election Board has expired and no such appeal has been filed.**

24 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby accepts**
25 **the apportionment of votes each district is entitled to cast on the Tohono O'odham**
26 **Legislative Council in accordance with the Certificate of District Residents dated May**
27 **26, 2007.**

28 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11TH Day of**
29 **[JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article V,**
31 **Section 2 and Article VI, Section 1(g) of the Constitution of the Tohono O'Odham Nation, adopted**
32 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat. 984).**
