

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Issuing Certificates of Election from the May 26, 2007 General Election for the Offices  
of Chairman and Vice-Chairman of the Nation and Representatives and Alternates to  
the Tohono O'odham Legislative Council and Seating Such Elected Officials)**

**LEGISLATIVE ORDER NO. 07-319**

1 **WHEREAS, on Saturday, May 26, 2007 the Tohono O'odham Election Board conducted a general**  
2 **election for the offices of chairperson of the Nation, vice-chairperson of the Nation,**  
3 **and representatives and alternates to the Tohono O'odham Legislative Council and**  
4 **district councils; and**

5 **WHEREAS, the Election Board issued and posted its Certificate of Election Results dated May 26,**  
6 **2007, which is incorporated by this reference, in accordance with Section 6.K. of Article**  
7 **VII of the Uniform Election Ordinance, Ordinance No. 03-86; and**

8 **WHEREAS, Section 6.N. of Article VII of the Uniform Election Ordinance requires that the**  
9 **Legislative Council issue Certificates of Election to the candidate who receives the**  
10 **highest number of votes for chairperson and vice-chairperson of the Nation and for**  
11 **each Legislative Council seat within 20 days after the Election Board has posted its**  
12 **Certificates of Election Results; provided, however, that (1) no election contest**  
13 **statement has been filed within the time allowed, (2) such a candidate holds no other**  
14 **elective public office of the Nation, and (3) that the chairperson-elect and vice-**  
15 **chairperson-elect resign any employment before being seated; and**

16 **WHEREAS, the period for contesting the 2007 general election has expired and no such contest**  
17 **has been filed in accordance with the requirements of Article VIII of the Uniform**  
18 **Election Ordinance.**

19 **NOW, THEREFORE, BE IT ORDERED that the Chairperson and Secretary of the Tohono**  
20 **O'odham Legislative Council are hereby authorized and directed on behalf of the**  
21 **Council to execute and deliver a Certificate of Election seating the following persons**  
22 **elected either at large as Chairman and Vice-Chairman of the Tohono O'odham Nation**  
23 **or from their respective districts as representatives and alternates to the Tohono**  
24 **O'odham Legislative Council; provided that all such persons shall hold offices in**  
25 **accordance with the Uniform Election Ordinance for a term of four years or until their**  
26 **successors have been elected, certified and seated, namely:**
