

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Certifying Election of Verlon M. Jose as Legislative Council Chairman)**

**LEGISLATIVE ORDER NO. 07-321**

1 **WHEREAS, during the June 11, 2007 general session, the Legislative Council did conduct an**  
2 **election for the office of the legislative chairperson in accordance with Article XII,**  
3 **Section 2 of the Legislative Rules of the Tohono O'odham Legislative Council; and**

4 **WHEREAS, each representative did cast their vote for one of the candidates nominated for said**  
5 **office with results as follows: Representative Verlon M. Jose received 1,393.5 votes;**  
6 **Representative Cynthia Manuel received 1,041.4 votes; Representative Chester Antone**  
7 **received 99.60 votes; and**

8 **WHEREAS, Representative Verlon M. Jose having received a majority of the votes cast was**  
9 **declared Legislative Chairman-elect in accordance with Legislative Rules, Article XII,**  
10 **Section 2.C.**

11 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**  
12 **does hereby certify the election of Representative Verlon M. Jose as Chairman of the**  
13 **Tohono O'odham Legislative Council.**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day of**  
15 **JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST; -0-**  
16 **NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Article VI, Section**  
17 **1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**  
18 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
19 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
