

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Certifying Election of Felicia Nuñez as Legislative Council Vice Chairwoman)**

**LEGISLATIVE ORDER NO. 07-323**

1 **WHEREAS, during the June 11, 2007 general session, the Legislative Council did conduct an**  
2 **election for the office of the legislative vice chairperson in accordance with Article XII,**  
3 **Section 2 of the Legislative Rules of the Tohono O'odham Legislative Council; and**

4 **WHEREAS, each representative did vote for one of the candidates nominated for said office;**  
5 **Representative Chester Antone received 829.95 votes; Representative Wavalene**  
6 **Romero received 819.45 votes; Representative Felicia Nuñez received 885.1 votes; and**

7 **WHEREAS, none of the candidates received the majority votes required to be deemed elected as**  
8 **vice chairperson, thereby resulting in a runoff between the top two candidates,**  
9 **namely, Representative Chester Antone and Representative Felicia Nuñez; and**

10 **WHEREAS, in the runoff election, Representative Chester Antone received 1,205.85 votes and**  
11 **Representative Felicia Nuñez received 1,328.65 votes; and**

12 **WHEREAS, Representative Felicia Nuñez, having received a majority of the votes cast, was**  
13 **declared the Legislative Vice Chairwoman-elect.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**  
15 **does hereby certify the election of Representative Felicia Nuñez as Vice Chairwoman**  
16 **of the Tohono O'odham Legislative Council.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day of**  
18 **JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST; -0-**  
19 **NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Article VI, Section**  
20 **1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**  
21 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
