

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Attorney Contract with Chandler & Udall LLP)**

RESOLUTION NO. 07-370

1 **WHEREAS, the Tohono O'odham Nation ("Nation") entered into an attorney contract with the law**
2 **firm of Chandler & Udall, LLP, for fiscal year 2007 to allow Steve Weatherspoon to**
3 **assist the Nation in preparation of a comprehensive Nation's Water Code and an**
4 **Interim Allottee Water Code, and other matters; and**

5 **WHEREAS, the attorney contract had a budget of \$20,000.00 for the period from October 1, 2006**
6 **to September 30, 2007; and**

7 **WHEREAS, during the year the work required of the attorney on the Nation's Water Codes**
8 **increased significantly in order to meet the December 31, 2007 deadline for notice of**
9 **fulfillment of requirements specified in the SAWRSA Amendments contained in the**
10 **Arizona Water Settlements Act of 2004; and**

11 **WHEREAS, some work performed in FY 2007 has exceeded the funds available in the budget, and**
12 **the agreement to pay for the work should be ratified by the Nation; and**

13 **WHEREAS, the Water Resources Committee and the District Water Advisory Committee**
14 **recommend that the budget be increased by \$80,000 to a total of \$100,000 for the**
15 **contract year.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
17 **Amendment No. 1 to the attorney contract with the law firm of Chandler & Udall, LLP,**
18 **for the year ending September 30, 2007, substantially in the form attached hereto, and**
19 **ratifies the amounts due which were incurred in excess of the budgeted amount, and**
20 **authorizes the Chairperson of the Nation to execute Amendment No. 1.**

21 **BE IT FINALLY RESOLVED that the attorney contract shall be funded from the interest**
22 **on the Nation's SAWRSA Trust Fund per Resolution No. 07-369.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
24 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 1,762.3 FOR; -0- AGAINST;**
25 **772.2 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)**
26 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
