

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Modification/Amendment #2 for Coldfields 2007 Budget, Correcting Line Item)**

RESOLUTION NO. 07-371

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on May 9,**
2 **2007, at which a quorum was present; and**

3 **WHEREAS, the Coldfields Representatives presented a request to modify/amend a line item in**
4 **their 2007 budget; and**

5 **WHEREAS, at a Coldfields community meeting held on May 7, 2007, members present, accepted**
6 **and approved to modify/amend the current budget line item 770.32-REPAIR &**
7 **MAINTENANCE VEHICLE to 771.32-REPAIR & MAINTENANCE VEHICLE, by a vote count**
8 **of 8-FOR; 0-AGAINST, 2-NOT VOTING; and**

9 **WHEREAS, this modification/amendment #2 will not affect Coldfields community's 2007 current**
10 **budget amount of \$176,603.20.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed**
12 **and approved the Coldfields Community 2007 budget line item correction of 770.32-**
13 **REPAIR & MAINTENANCE VEHICLE to 771.32-REPAIR & MAINTENANCE VEHICLE, which**
14 **will not affect their current 2007 budget amount of \$176,603.20.**

15 **BE IT FINALLY RESOLVED that any changes in the justifications, additions and/or transfer of funds**
16 **between budget line items are to be reviewed and approved by the Budget & Finance**
17 **Committee and the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
19 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**
21 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
