

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving 2007 Continuing Separate Budget for Fresnal Canyon Community
Utilizing FY 2005 Carryover Monies)**

RESOLUTION NO. 07-372

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on December**
2 **11, 2006, of which a quorum was present; and**

3 **WHEREAS, the Fresnal Canyon Representatives presented a request to utilize 2005 carryover**
4 **monies in the amount of \$82,794.84 and create a continuing separate budget with the**
5 **line item 772.32-R/M Building only; and**

6 **WHEREAS, at a Fresnal Canyon community meeting, held on December 4, 2006, community**
7 **members present, accepted and approved the continuing separate budget, by a vote**
8 **count of 10-FOR, 0-AGAINST, 1-NOT VOTING; and**

9 **WHEREAS, this amendment will not affect the Fresnal Canyon's original 2007 budget of**
10 **\$109,469.09; and**

11 **WHEREAS, after review, the Baboquivari District Council has approved Fresnal Canyon's request**
12 **to create a continuing separate budget in the amount of \$82,794.84, with the line item**
13 **of 772.32-R/M Building only, utilizing 2005 carryover monies; and**

14 **WHEREAS, this continuing separate budget will deplete Fresnal Canyon's 2005 carryover monies.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
16 **Fresnal Canyon's creation of a continuing separate budget in the amount of \$82,794.84**
17 **with line item 772.32-R/M Building only, utilizing 2005 carryover monies, and does not**
18 **affect their original 2007 budget of \$109,469.09.**

19 **BE IT FINALLY RESOLVED that any changes in the justifications, additions and/or transfer of funds**
20 **between budget line items are to be reviewed and approved by the Budget & Finance**
21 **Committee and the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH. Day**
23 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
25 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
