

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 07 Department of Health and Human Services – Community Counseling and Relations Services (CCRS) Savings Budget Amendment No. 1 (Account 10-1450) to increase the Indirect Cost Rate from 17.98% to 19.35% )**

**RESOLUTION NO. 07-383**

1 **WHEREAS, the Tohono O'odham Nation did renegotiate the indirect cost rate to apply to the fiscal**  
2 **year 2006-2007; and**

3 **WHEREAS, the new indirect cost rate has been raised from 17.98% to 19.35%; and**

4 **WHEREAS, the new indirect cost rate will be applied to the 2006-2007 fiscal year and to future**  
5 **budgets until such time as a new rate is negotiated and accepted; and**

6 **WHEREAS, the attached budget grand total amount has increased from \$9,512.67 to \$12,783.42;**  
7 **and**

8 **WHEREAS, savings dollars for Community Counseling and Relations (CCRS) program, Account**  
9 **No.10-1450 has been identified as: savings \$103,127.09 plus base amount of \$43,396.00**  
10 **minus current expenses of \$36,112.92 leaving a total amount available of \$110,410.17.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
12 **approve the budget attached as follows:**

13 **1. Adjusting the Indirect Cost Rate to 19.35% for FY 07.**

14 **2. Utilize savings dollars as identified for Community Counseling and Relations**  
15 **(CCRS) program as: savings amount available \$103,127.09 adding base amount**  
16 **of \$43,396.00 minus current expenses of \$36,112.92 leaving a total amount**  
17 **available of \$110,410.17.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
19 **Nation officials, to wit: the Chairperson and any designated official are hereby**  
20 **authorized to negotiate and execute the contract, provided however, that any**  
21 **amendments affecting the funds or funding levels of the contract shall be submitted**  
22 **for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
24 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**  
26 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**




