

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Child Care Mandatory Administration Budget Modification/  
Amendment 1-Account # 11-1217)**

**RESOLUTION NO. 07-387**

1 **WHEREAS, the Tohono O'odham Nation through the Child Care Program has been successfully**  
2 **providing services and assistance to eligible Tohono O'odham children and families;**  
3 **and**

4 **WHEREAS, the Child Care program, through the Grants and Contracts Office has received the**  
5 **allocation of \$189,420.52 for Child Care Mandatory Administration account #11-1217;**  
6 **and**

7 **WHEREAS, the Child Care program budget modification/amendment #1 reflects a decrease in**  
8 **account #11-1217 , line item 610 in the amount of \$9,601.29; and**

9 **WHEREAS, the Child Care program budget modification/amendment #1 reflects a decrease In**  
10 **account 11-1217, line item 620 in the amount of \$2,976.40;and**

11 **WHEREAS, the Child Care program budget modification/amendment #1 reflects an Increase in**  
12 **account #11-1217 , line item 710 in the amount of \$7,000; and**

13 **WHEREAS, the Child Care program budget modification/amendment #1 reflects an Increase in**  
14 **account #11-1217 , line item 711 in the amount of \$3,565.54.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
16 **the Child Care program budget modification / amendment 1 in the amount of**  
17 **\$12,577.69 and the creation of line item 772 RM Building.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairperson is hereby authorized to**  
19 **negotiate and execute the budget provided that any amendment affecting the funding**  
20 **or funding levels of the budget shall be submitted for approval by the Tohono**  
21 **O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
23 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
24 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**  
25 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
