

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Head Start Program FY 2007 Budget Modification 2- Account #11-1218)**

RESOLUTION NO. 07-388

1 **WHEREAS, the Tohono O'odham Nation through the Head Start Program has been successfully**
2 **providing services and assistance to eligible Tohono O'odham children and families;**
3 **and**

4 **WHEREAS, the Head Start Program Grant, through the Grants and Contracts Office has received**
5 **the allocation of \$1,424,374.84; and**

6 **WHEREAS, the Head Start Program modification #2 reflects a decrease in line item 610 of**
7 **\$14,807.06, a decrease in line item 620 of \$4,555.90, decrease in line item 630 of**
8 **\$1,322.25, and reflects a decrease in line item 751 of \$30,000.00; and**

9 **WHEREAS, the Head Start Program modification #2 increases line item 660 by \$7,000.00,**
10 **increases line item 712 by \$8,000.00, increases line item 721 by \$5,685.21, and**
11 **increases line item 750 by \$42,798.56; and**

12 **WHEREAS, the Indirect Cost Charges line item 900 decreased by \$12,798.56.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the Head Start Program Grant budget modification #2 decreasing the amount of**
15 **indirect cost charges by \$12,798.56.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairperson is hereby authorized to**
17 **negotiate and execute the budget provided that any amendment affecting the funding**
18 **or funding levels of the budget shall be submitted for approval by the Tohono**
19 **O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
21 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**
23 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
