

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Cardiovascular Disease (CVD) Risk Reduction in Diabetes Clients Grant,
Special Diabetes Programs for Indians Competitive Grant # 1 H1D 94 00537-01
(October 1, 2006 – September 30, 2007))**

RESOLUTION NO. 07-390

1 **WHEREAS, the Tohono O'odham Nation has applied for and has been approved to receive**
2 **\$397,100 in competitive funding from Special Diabetes Programs for Indians monies;**
3 **and**

4 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**
5 **Fiscal Year 2007 base budget of \$397,100 be amended to reflect the indirect cost rate**
6 **from 17.98% to 19.35%; and**

7 **WHEREAS, the amended Fiscal Year 2007 CVD risk reduction program base budget has been**
8 **reviewed by Health and Human Services Oversight Committee and Budget and Finance**
9 **Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
11 **authorizes the expenditures of the FY2007 Division of Health Promotion CVD risk**
12 **reduction (Ihptak Ap' e dag) program budget of \$397,100, reflecting the indirect cost**
13 **rate change from 17.98% to 19.35%, in accordance with the attached budget**
14 **amendment.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation Officials, to wit: the Chairperson and any designated Official are hereby**
17 **authorized to negotiate and execute the grant, provided however, that any**
18 **amendments affecting the funds or funding levels of the grant shall be submitted for**
19 **further approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
21 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
23 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
