

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance
- FY07 Food Distribution Program Budget Amendment #1 - Account No. 11-1315)

RESOLUTION NO. 07-391

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2007 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution No. 06-186, the Tohono O'odham Legislative Council approved the**
5 **FY2007 Food Distribution Program budget in the amount of \$181,138.00; and**

6 **WHEREAS, the Nation was notified of an approved Indirect Cost Rate of 19.35% for this USDA**
7 **budget, and**

8 **WHEREAS, Food Distribution Program funds available to the Tohono O'odham Nation for FY2007**
9 **through the USDA has decreased by \$1.00, from \$181,138.00 to \$181,137.00; and**

10 **WHEREAS, the Department of Health and Human Services has prepared the attached FY2007**
11 **USDA Food Distribution Program 11-1315 Budget Amendment #1 which incorporates**
12 **the 19.35% Indirect Cost Rate, and also changes amounts in personnel and operations**
13 **line items; and has presented these to the Tohono O'odham Legislative Council**
14 **Committees; and**

15 **WHEREAS, Budget Amendment #1 decreases line items: Salaries \$7,112.91, Fringe Benefits \$2,205,**
16 **and increases line items: Tuition and Registration \$300.00, Travel Expense \$750.08,**
17 **Gas, Oil and Coolants \$4,591.00, Supplies Other \$213.61, Dues and Subscriptions**
18 **\$200.00, RM Vehicles \$1,500.00, and Indirect Cost \$1,762.23. The total budget amount**
19 **also reflects the decrease from \$181,138.00 to \$181,137.00.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **approve and authorize the Executive Branch to expend funds in the attached FY2007**
22 **USDA Food Distribution Program Budget Amendment #1, effective October 01, 2006**
23 **through September 30, 2007, which budget modification incorporates changes for**
24 **personnel, and operations line items and approved 19.35% Indirect Cost Rate during**
25 **this period.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
27 **Chairperson, and any designated official authorized to expend and administer the**
28 **budget amendment as attached, provided that any amendments affecting the funds**
