

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 07 Department of Health and Human Services – Community Counseling
and Relations Services (CCRS) Base Budget Amendment No. 1 (Account 10-1450) to
increase the Indirect Cost Rate from 17.98% to 19.35%)

RESOLUTION NO. 07-394

1 **WHEREAS, the Tohono O'odham Nation did renegotiate the indirect cost rate to apply to the fiscal**
2 **year 2006-2007; and**

3 **WHEREAS, the new indirect cost rate has been raised from 17.98% to 19.35%; and**

4 **WHEREAS, the new indirect cost rate will be applied to the 2006-2007 fiscal year and to future**
5 **budgets until such time as a new rate is negotiated and accepted; and**

6 **WHEREAS, the attached budget grand total amount has increased from \$50,851.74 to \$51,442.24.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
8 **approve the budget attached as follows:**

9 **1. Adjusting the new indirect cost rate to 19.35%.**

10 **2. Increasing base budget amount from \$50,851.74 to \$51,442.24.**

11 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
12 **Nation officials, to wit: the Chairperson and any designated officials are hereby**
13 **authorized to negotiate and execute the contract, provided however, that any**
14 **amendments affecting the funds or funding levels of the contract shall be submitted**
15 **for further prior approval by the Tohono O'odham Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
17 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2)&**
19 **(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**
