

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Violet Lui-Frank Judge Pro Tempore of the Tohono O'odham Courts)**

RESOLUTION NO. 07-398

1 **WHEREAS, the Legislative Council is empowered by Article VIII, Section 4 of the Constitution of**
2 **the Tohono O'odham Nation to appoint judges of the Tohono O'odham Courts; and**

3 **WHEREAS, the Legislative Council did by Ordinance No. 01-89, Chapter II, authorize the**
4 **appointment of judge pro tempore to the Tohono O'odham Courts upon the**
5 **recommendation of the Chief Judge; and**

6 **WHEREAS, the Chief Judge has submitted the name of Violet Lui-Frank, who is qualified pursuant**
7 **to 2-103 of Ordinance No. 01-89, and recommends her appointment as judge pro**
8 **tempore of the Tohono O'odham Judicial Courts; and**

9 **WHEREAS, Ordinance 01-89, Chapter II allows the appointment of a judge pro tempore for a term**
10 **of no greater than six years; and**

11 **WHEREAS, the Chief Judge has submitted the name of Violet Lui-Frank, who is qualified to serve**
12 **as a judge pro tempore; and**

13 **WHEREAS, the Judiciary Committee has determined that the person recommended is of good**
14 **moral character, resident of the State of Arizona for not less than five years, and has**
15 **been admitted to the practice of law for not less than three years; and**

16 **WHEREAS, the Judiciary Committee does concur with the recommendation of the Chief Judge and**
17 **recommends to the full Legislative Council the appointment of Violet Lui-Frank judge**
18 **pro tempore.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does accept**
20 **the recommendation of the Chief Judge and hereby appoints Violet Lui-Frank as judge**
21 **pro tempore of the Tohono O'odham Judicial Court for a term beginning June 1, 2007**
22 **and ending May 31, 2011.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
24 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,143.6 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and 390.9[06] ABSENT, pursuant to the powers vested in the Council by Section**
26 **4 of Article VIII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
