1	WHEREAS, the Legislative Council is empowered by Article VIII, Section 4 of the Constitution of
2	the Tohono O'odham Nation to appoint judges of the Tohono O'odham Courts; and
3	WHEREAS, the Legislative Council did by Ordinance No. 01-89, Chapter II, authorize the
4	appointment of judge pro tempore to the Tohono O'odham Courts upon the
5	recommendation of the Chief Judge; and
6	WHEREAS, the Chief Judge has submitted the name of Violet Lui-Frank, who is qualified pursuant
7	to 2-103 of Ordinance No. 01-89, and recommends her appointment as judge pro
8	tempore of the Tohono O'odham Judicial Courts; and
9	WHEREAS, Ordinance 01-89, Chapter II allows the appointment of a judge pro tempore for a term
10	of no greater than six years; and
11	WHEREAS, the Chief Judge has submitted the name of Violet Lui-Frank, who is qualified to serve
12	as a judge pro tempore; and
13	WHEREAS, the Judiciary Committee has determined that the person recommended is of good
14	moral character, resident of the State of Arizona for not less than five years, and has
15	been admitted to the practice of law for not less than three years; and
16	WHEREAS, the Judiciary Committee does concur with the recommendation of the Chief Judge and
17	recommends to the full Legislative Council the appointment of Violet Lui-Frank judge
18	pro tempore.
19	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does accept
20	the recommendation of the Chief Judge and hereby appoints Violet Lui-Frank as judge
21	pro tempore of the Tohono O'odham Judicial Court for a term beginning June 1, 2007
22	and ending May 31, 2011.
