

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2007 budget amendment # 3 by increasing budget by adding savings of \$185,420.62 changing budget amount from \$3,890,182.06 to 4,099,871.57 and creating new line items 712 & 771)**

**RESOLUTION NO. 07-400**

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**  
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) is increasing its 638 Law**  
4 **Enforcement budget with savings of \$185,420.62; and**

5 **WHEREAS, the TONPD is amending its 638 budget by adding the amount of \$185,420.62 to create**  
6 **new line items 712 Gas, Oil & Coolants, 771 R&M of vehicles and increasing line item**  
7 **750 Capital equipment; and**

8 **WHEREAS, the TONPD is also including the 2.5% increase for the position of the System**  
9 **Administrator that was not included in the salary of \$39,266.03 for the FY 2007 amount**  
10 **a difference of \$981.65 bringing total salary for FY 2007 to \$40,247.68; and**

11 **WHEREAS, the increase of the System Administrator also increase the line items 610.5 other**  
12 **compensation and 620 Fringe benefits; and**

13 **WHEREAS, with the increase of \$185,420.62 this changes the budget amount form \$3,890,182.06**  
14 **to \$4,099,871.57.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
16 **approves and authorizes Budget Amendment No.3 for the following:**

- 17 **1) Increases the 638 Law Enforcement budget by adding savings in \$185,420.62**  
18 **bringing total from \$3,890,182.06 to \$4,099,871.57.**
- 19 **2) Creates new line items 712 Gas, Oil & Coolants, 771 R&M of vehicles.**
- 20 **3) Amending justification of 750 Capital to include purchase of two vehicles which**  
21 **increases line item 750 Capital Equipment by \$60,000.00.**
- 22 **4) Increase in the Indirect cost from \$544,618.12 to \$568,887.01 a difference of**  
23 **\$24,268.89.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
25 **Chairperson and any designated official to expend and administer the budget as**  
26 **attached, provided that any amendments affecting the funds or funding levels shall**  
27 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
29 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,087.95 FOR; 90.55**  
30 **AGAINST; 356.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
31 **Section 1 d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
32 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat. 984).**


