

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Coldfields 2007 Budget Amendment #3, Utilizing PY's 2000, 2001, 2002, 2003, & 2006 Carryover Dollars)**

RESOLUTION NO. 07-406

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on June 9,**  
2 **2007, of which a quorum was present; and**

3 **WHEREAS, the Coldfields Community Representatives presented a request to amend their 2007**  
4 **budget, utilizing PY's 2000-\$75,796.52, 2001-20,779.35, 2002-\$12,550.26, 2003-\$8,362.32**  
5 **& 2006-\$23,200.11 carryover dollars in the amount of \$140,688.56; and**

6 **WHEREAS, at a Coldfields community meeting held on May 20, 2007, community members**  
7 **present approved the budget amendment #3; and**

8 **WHEREAS, the budget amendment shall be as follows:**

19 **Coldfields and will increase their 2007 budget to a total of \$316,791.76.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed**  
21 **and approved Coldfields Community's 2007 budget amendment #3, to utilize 2000,**  
22 **2001, 2002, 2003 & 2006 carryover dollars, in the amount of \$140,688.56 to the above**  
23 **mentioned line items and also depleting carryover dollars for 2000, 2001, 2002, 2003**  
24 **& 2006 for a new total budget amount for Coldfields Community of \$316,791.76.**

25 **BE IT FINALLY RESOLVED that any changes in the justifications, additions and/or transfer of funds**  
26 **between budget line items are to be reviewed and approved by the Budget & Finance**  
27 **Committee and the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>. Day**  
29 **of JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
30 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**  
31 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
32 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
33 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
