1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on May 22,**
2 **2007, at which a quorum was present; and**

3 **WHEREAS, the Artesia/Little Tucson Community Representatives presented a request for a budget**
4 **modification/amendment #1 to their 2007 budget, utilizing 2000-\$59,378.85 and 2003-**
5 **\$24,832.71 carryover dollars; and**

6 **WHEREAS, at an Artesia/Little Tucson community meeting, held on January 21, 2007, members**
7 **present approved budget modification/amendment #1 by a vote count of 15-FOR, 0-**
8 **AGAINST, 0-NOT VOTING; and**

9 **WHEREAS, the budget modification will be applied to the following line items:**

29 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
30 **Artesia/Little Tucson's 2007 budget modification/amendment #1, to modify salary line**
31 **items 610.32-Salaries and 620.32-Fringe Benefits; and amend above mentioned line**
32 **items in the amount of \$84,211.56, utilizing and depleting 2000 and 2003 carryover**
33 **dollars, for a new budget total of \$193,680.65.**


