

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Legislative Order No. 07-402, "Adopting Tohono O'odham Legislative Council  
Committee Meeting Schedule thru May 2009")**

**LEGISLATIVE ORDER NO. 07-408**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**

5 **WHEREAS, the Rules Committee has been charged with developing the Legislative Council**  
6 **Committee Meeting Schedule for the 2007-2009 Legislative Session; and**

7 **WHEREAS, due to conflicts in the committee meeting schedules, it is necessary to amend the**  
8 **committee meeting schedule adopted by Legislative Order No. 07-402.**

9 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
10 **amends Legislative Order No. 07-402 to adopt the amended Legislative Council**  
11 **Committee Meeting Schedule for June 2007 through June 2009 as presented by the**  
12 **Rules Committee.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>. Day of**  
14 **JUNE, 2007 at a meeting at which a quorum was present with a vote of 2,246.8 FOR; 287.7 AGAINST;**  
15 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
16 **Section 1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
17 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
18 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
