

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Base Roll Addition)**

**RESOLUTION NO. 07-417**

1 **WHEREAS, Section 1(a) of Article II of the Constitution of the Tohono O'odham Nation provides**  
2 **that the Tohono O'odham Council can make additions and changes to the official**  
3 **census rolls of the Sells and Gila Bend Reservations dated January 1, 1937 and of the**  
4 **San Xavier Reservation dated January 1, 1940, subject to the approval of the**  
5 **Secretary of the Interior; and**

6 **WHEREAS, the Enrollment Committee has determined that the following named person(s) was**  
7 **a member of the Tohono O'odham Nation on the date of the respective census rolls**  
8 **but that their name(s) had been inadvertently omitted therefrom, and had**  
9 **recommended that their name(s) be added to the rolls; and**

10 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the Enrollment**  
11 **and approves thereof.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that subject to the approval**  
13 **of the Secretary of the Interior, the name(s) of the following person(s) be added to the**  
14 **official census rolls of the Sells, Gila Bend, or San Xavier Reservations to wit:**

15 **3328-ND-98            Garcia-Napoleon, Francisco**

16 **7882-ND-03            Rodriguez-Napoleon, Maria**

17 **BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of the**  
18 **Interior before their name(s) be formally added such rolls.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
20 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 1,844.85 FOR; 517.65**  
21 **AGAINST; 172.0 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1(a) of Article II and Section 1(h) of Article IV of the Constitution of the Tohono O'Odham**  
23 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
24 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
25 **of the Act of June 18, 1934 (48 Stat. 984).**
