6	Fund for Grant Year 2006 to implement Child Care Services through the Division of
7	Early Childhood Development; and
8	WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year 2006
9	remaining funds will be obligated by September 30, 2006 and liquidated by September
10	30, 2007; and
11	WHEREAS, the Division of Early Childhood Development has submitted for review and approval
12	the proposed FY 2007 Child Care & Development Fund Budget for Grant Year 2006
13	Discretionary Program unobligated funds totaling \$156,848.
14	NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council does hereby
15	approve the FY 2007 Child Care & Development Fund Budget for Grant Year 2006
16	remaining funds for a total of \$156,848.00 for the following budget:

20	Nation's Official, to wit: the Chairman and any designated official are authorized to
21	negotiate and expend the budget, provided however, that any amendments affecting
22	the funds or funding  levels  of the  budget  shall  be  submitted  for  further  prior  approval.
