7	Park Budget to use the funds to cover expenses; and								
8	WHEREAS, the budget line item: 778 is specific and to add the wording: INCLUDES BUT NOT								
9	LIMITED TO.								
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves								
11	Budget amendment to change the justification for items #778, to add the wording								
12	INCLUDES BUT NOT LIMITED TO: FY 2007, Veterans Memorial Monument and Park
