1	WHEREAS,	the Tohono O'odham Nation has historically contracted certain functions from the
2		United States Department of Health and Human Services; and
3	WHEREAS,	the Tohono O'odham Nation has operated and wishes to continue operating a Division
4		of Child Welfare Services to intervene against child abuse and neglect and to promote
5		safe and stable families; and
6	WHEREAS,	the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation matches
7		through the P.L. 93-638 Master Contract, as authorized by P.L. 93-638 and the U.S.
8		Department of Health and Human Services; and
9	WHEREAS,	in Resolution No. 05-568, the Legislative Council approved:
10		1. \$130,319.00 for FY06 Title IV-B, Subpart 1 Budget Acct. 11-1333.
11		2. \$122,090.00 for FY06 Title IV-B, Subpart 2 Budget Acct. 11-1334; and
12	WHEREAS,	these Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two-year expenditure
13		period, beginning October 1, 2005 and ending September 30, 2007, funding only the
14		two fiscal years of FY 2006 and FY 2007; and
15	WHEREAS,	the United States Department of Health and Human Services had later determined a
16		final allocation amount for these budgets as:
17		1. \$128,940.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1333.
18		2. \$117,672.00 for Title IV-B, Subpart 2 Budget, Acct. 11-1334; and
19	WHEREAS,	the Division of Child Welfare Services had partially expended these funds as
20		authorized in FY 2006, leaving the following remaining balances available in FY 2007
21		for these budgets:
22		1. \$64,057.17 for FY07 Title IV-B, Subpart 1 Budget Acct. 11-1333.
23		2. \$25,956.49 for FY07 Title IV-B, Subpart 2 Budget Acct. 11-1334; and
24	WHEREAS,	the Executive Branch developed and obtained committee approval of the budgets
25		attached and incorporated by this reference, to be effective October 1, 2006 through
26		September 30, 2007 and requests authorization to expend the remaining funds in FY $$
