

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Consolidated Healthy O'odham Promotion Program FY 2007 Budget Modification #2
October 1, 2006 - September 30, 2007)

RESOLUTION NO. 07-443

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**
2 **through FY 2009 with a base budget of \$1,929,827.00 and carryover funding of**
3 **\$3,529,100.56 for a total budget of \$5,458,927.56; and**

4 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the**
5 **establishment of the Community Based Diabetes Prevention Program, funded by the**
6 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of 1997;**
7 **and**

8 **WHEREAS, by Resolution Number 2000-182, the Tohono O'odham Legislative Council approved**
9 **the name change of the Community Based Diabetes Prevention Program to the**
10 **Healthy O'odham Promotion Program; and**

11 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**
12 **Fiscal Year 2007 total budget of \$5,458,927.56 be modified to increase/decrease line**
13 **items and to change indirect cost rate from 17.98% to 19.35%.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 15 **1. Approve Base Budget of \$1,929,827.00 and carryover funding of \$3,529,100.56 for**
16 **a total budget of \$5,458,927.56.**
- 17 **2. Approves line items increases and decreases.**
- 18 **3. Approves the new indirect cost rate from 17.98% to new IDC rate of 19.35%.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairman, Vice-Chairman, and any designated official to expend and administer the**
21 **budget as attached, provided that any amendments affecting the funds or funding**
22 **level shall be submitted for further final approval by the Tohono O'odham Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
25 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2)**
27 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
