

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 07 Department of Health and Human Services Budget Mod./Amendment**  
**No. 1 for STOP Domestic Violence Among Indian Women (Account 11-1421) to adjust**  
**Indirect Cost Rate from 17.98% to 19.35% and cover anticipated over-expenditures**  
**through the end of the fiscal year)**

**RESOLUTION NO. 07-444**

1 **WHEREAS, the Tohono O'odham Nation did renegotiate the indirect cost rate to apply to the fiscal**  
2 **year 2006-2007; and**

3 **WHEREAS, the new indirect cost rate has been raised from 17.98% to 19.35%; and**

4 **WHEREAS, the new indirect cost rate will be applied to 2006-2007 fiscal year and to future budgets**  
5 **until such time as a new rate is negotiated and accepted; and**

6 **WHEREAS, the attached budget modification grand total remains at \$117,963.00; and**

7 **WHEREAS, the attached budget modification has been modified to apply the new indirect cost**  
8 **rate and increase/decrease line item amounts to cover anticipated over-expenditures**  
9 **for the fiscal year.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
11 **approve the amended budget attached adjusting the Indirect Cost Rate to 19.35% for**  
12 **FY 07 and increasing/decreasing line item amounts to cover anticipated over-**  
13 **expenditures and carry the program through the end of the fiscal year.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Nation officials, to wit: the Chairman and Vice Chairman and any designated official**  
16 **are hereby authorized to negotiate and execute the contract, provided however, that**  
17 **any amendments affecting the funds or funding levels of the contract shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
20 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,352.1 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and 182.4 [05] ABSENT, pursuant to the powers vested in the Council by Section**  
22 **1(d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
