

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Community Based
Diabetes Program-Steps Program Budget Amendment No. 1)**

RESOLUTION NO. 07-445

1 **WHEREAS, the Tohono O'odham Legislative Council approved resolution No. 06-203 "Approving**
2 **STEPS to a Healthier US Grant, STEPS to a Healthier Arizona Initiative (October 1, 2006**
3 **- September 30, 2007)" including the authorizing budget of \$436,941.00; and**

4 **WHEREAS, the Arizona Department of Health and Human Services notified the Tohono O'odham**
5 **Nation of the final allocation for FY-2007 in the amount of \$350,000.00; and**

6 **WHEREAS, the FY-2007 Steps original approved budget is amended to decrease the budget by**
7 **\$89,878.85 to reflect \$350,000.00; and**

8 **WHEREAS, FY-2007 Steps budget is amended to reflect indirect cost rate changes from 17.98% to**
9 **19.35%.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 11 **1. Approves the Division of Health Promotion Tohono O'odham Steps Program**
12 **amended budget from \$436,941.00 to \$350,000.00 for FY-2007, to reflect the**
13 **indirect cost rate change from 17.98% to 19.35%.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairman, Vice Chairman and any designated official to expend and administer the**
16 **budget as attached, provided that any amendments affecting the funds or funding**
17 **level shall be submitted for further final approval by the Tohono O'odham Legislative**
18 **Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH. Day**
20 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,340.1 FOR; 194.4**
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1(d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
23 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
