

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Community Based Diabetes**  
**Program - Steps Program Budget Amendment No. 2)**

RESOLUTION NO. 07-446

1 WHEREAS, the Tohono O'odham Legislative Council approved resolution No. 07-445, "Approving  
2 Steps to a Healthier U.S." Grant, Steps to a Healthier Arizona Initiative (October 1, 2006  
3 - September 30, 2007) including the authorizing budget of \$350,000.00; and

4 WHEREAS, the Arizona Department of Health Services has increased the funding level by  
5 \$1,600.00 to supplement the program for travel cost for the program coordinator to  
6 attend the Annual Steps to a Healthier US meeting.


7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:

- 8 1. The FY-2007 Steps program hereby amend their current budget to \$351,600.00,  
9 to reflect the increase of \$1,600.00.
- 10 2. Approves the Division of Health Promotion Tohono O'odham Steps Program  
11 amended budget of \$351,600.00 for FY-2007.

12 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
13 Chairman, Vice-Chairman and any designated official to expend and administer the  
14 budget as attached, provided that any amendments affecting the funds or funding  
15 level shall be submitted for further final approval by the Tohono O'odham Legislative  
16 Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day  
18 of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
19 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3)  
20 and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
21 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
23 Stat. 984).
