

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to Close-Out the P.L. 93-638 Employment Assistance Program FY 2007 Budget,
Close Out Account #10-1206 and Creating & Establishing a New Account Number)

RESOLUTION NO. 07-454

1 **WHEREAS, Tohono O'odham Nation through Legislative Council Resolution No. 06-212 entitled**
2 **“Approving the FY2007 Bureau of Indian Affairs Budgets under the Nation's P.L. 93-638**
3 **Master Contract” included the Employment Assistance Program and authorized**
4 **posting of the budget to the American Fundware System; and**

5 **WHEREAS, pursuant to Legislative Council Resolution No. 07-035 the Tohono O'odham Nation**
6 **approved merging the Employment Assistance Program under the Nation's 477**
7 **Program authorizing one consolidated budget of various funding streams; and**

8 **WHEREAS, the budget for the Employment Assistance Program, budget number 10-1206 now**
9 **requires close-out of \$315,610.41 to a zero balance in order to allow the program to**
10 **budget for prior year saving occurring under the BIA Master Contract and avoid**
11 **duplication of fund usage; and**

12 **WHEREAS, the Grants & Contract Office has identified the Employment Program has a remaining**
13 **balance in the amount of \$19,199.44 in account #10-1206 and now requires a new**
14 **account number for expenditure of allowances and stipends for clients under Adult**
15 **Vocational Training and Direct Employment.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **approve the close out of account #10-1206 in the amount of \$315,610.41 and now**
18 **assigns the remaining balance in the amount of \$19,199.44 by creating and**
19 **establishing a new account number. The Adult Vocational Training and Direct**
20 **Employment have merged with the Tohono O'odham Nation 477 Program for future**
21 **funding.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation's Officials, to wit; the Chairperson is hereby authorized to negotiate and**
24 **execute the contracts and plans, provided however, that any amendment affecting the**
25 **funding or funding levels of this contract shall be submitted for further prior approval**
26 **by this Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH. Day**
28 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,443.95 FOR; -0- AGAINST;**
29 **90.55 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3)**
30 **& 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
