6	WHEREAS, the account #10-1206 will be closed out due to Employment Assistance Program
7	merging with the Tohono O'odham Nation's One Stop Division 477 Program; and
8	WHEREAS, the remaining balance of \$19,199.44 requires a creation and establishment of a new
9	account number in the FY 2007 Budget, and upon expenditure of the remaining
10	balance of \$19,199.44 this account will zero out. Line item 626 Allowance and Stipends
11	is not affected by the Indirect Cost Rate; and
12	WHEREAS, the Human Resources Development and Budget and Finance Committees have
13	reviewed the Adult Vocational Training and Direct Employment Budget.
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
15	approve the FY 2007 budget in the amount of \$19,199.44 for the Adult Vocational
16	Training and Direct Employment.

18	Nation's Officials, to wit; the Chairperson is hereby authorized to negotiate and
19	execute the contracts and plans, provided however, that any amendment affecting the
20	funding or funding levels of this contract shall be submitted for further prior approval
21	by this Council.
