## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Amending Resolution No. 06-153, "Approving FY 2007 Projected Revenues in the Amount of \$47,767,883" to Increase Projected Revenues" to the Nation)

RESOLUTION NO. 07-459

1	WHEREAS, the Legislative Council is vested with the power "to manage any funds within the
2	exclusive control of the Tohono O'odham Nation" (Constitution of the Tohono
3	O'odham Nation, Article VI, Section 1(d)(2)); and
4	WHEREAS, the Legislative Council previously adopted FY 2007 projected revenues to the Nation
5	in the amount of \$47,767,883 (Resolution No. 06-153); and
6	WHEREAS, the Budget and Finance Committee has reviewed more recent FY 2007 revenue
7	projections and recommends that the FY 2007 projected revenues to the Nation
8	adopted by Resolution No. 06-153 be amended and increased by \$2,134,699, thereby
9	increasing the total FY 2007 projected revenues to the Nation from \$47,767,883 to
10	\$49,902,582.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends
12	Resolution No. 06-153 to increase FY 2007 projected revenues to the Nation by
13	\$2,134,699 thereby increasing the total FY 2007 projected revenues to the Nation from
14	\$47,767,883 to \$49,902,582.
15	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13 <sup>TH</sup> . Day
16	of <u>IULY, 2007</u> at a meeting at which a quorum was present with a vote of <u>2,443.95</u> FOR; <u>-0-</u> AGAINST;
17	90.55 NOT VOTING; and $[02]$ ABSENT, pursuant to the powers vested in the Council by Section $1(d)(2)$
18	of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
19	Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
20	(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
