

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2008 Projected Revenues to the Nation in the Amount of \$72,410,000)**

**RESOLUTION NO. 07-460**

1 **WHEREAS, the Budget and Finance Committee and the Executive Office reviewed the revenue**  
2 **projections and available revenue for FY 2008; and**

3 **WHEREAS, the Budget and Finance Committee and the Executive Office recommend the adoption**  
4 **of the FY 2008 revenue projections in the amount of \$72,410,000 to fund the Nation's**  
5 **budgets for FY 2008.**

6 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
7 **approves the attached projected revenues in the amount of \$72,410,000 for the**  
8 **purpose of funding the FY 2008 budgets of the Tohono O'odham Nation.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day**  
10 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
11 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2)**  
12 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
13 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
14 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


