10	WHEREAS, the TOKA Board has four vacancies and is currently unable to achieve a quorum to						
11	conduct business; and						
12	WHEREAS, the Legislative Housing Committee has interviewed TOKA Board candidate Glori						
13	Johnson Bracamonte and recommends that she be appointment to the Board of						
14	Directors effective immediately for a term ending the last day of February 2011 or unti						
15	her successor is appointed.

17	Gloria Johnson Bracamonte to a vacant position on the Tohono O'odham Ki:K
