

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Modification/Amendment #1 to the Sif-Oidak District FY 2007 Budget)**

RESOLUTION NO. 07-466

1 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 06-468, "Approving the**
2 **Sif-Oidak District FY 2007 Budget"; and**

3 **WHEREAS, the Sif-Oidak District Council, at an emergency meeting held on May 30, 2007 passed**
4 **Resolution No. 05-07-13, "Approving Modification/Amendment #1 to the Sif-Oidak**
5 **District FY 2007 budget"; and**

6 **WHEREAS, an amendment was necessary to increase the number of recipients from 81-84 under**
7 **the justification for Line item (867) Bonus; and**

8 **WHEREAS, a budget modification was also made to increase the Line item (867) Bonus by \$1,500**
9 **for a new revised total of \$42,000 and decrease Line item (820) Clothing Allowance by**
10 **\$1,500 for a new revised total of \$103,500; and**

11 **WHEREAS, the revised totals do not affect the overall budget in any way and is recommended to**
12 **be retroactive to December 2006; and**

13 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee did review the**
14 **Modification/Amendment on June 26, 2007 and recommends approval.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Branch that it does**
16 **hereby approve the Modification/Amendment #1 to the Sif-Oidak District FY 2007**
17 **Budget as presented.**

18 **BE IT FURTHER RESOLVED that the Modification/Amendment #1 will be retroactive to December**
19 **2006.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Officials to-wit: the Chairman and any designated Official, are authorized to**
22 **execute the budget, provided however, that any amendments affecting the funds or**
23 **funding levels of the budget shall be submitted for further prior approval by the**
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
26 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section**
28 **1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**


