

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment #2 to the Sif-Oidak District FY 2007 Budget)**

RESOLUTION NO. 07-467

1 WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 06-468, "Approving the  
2 Sif-Oidak District FY 2007 Budget"; and

3 WHEREAS, the Sif-Oidak District Council, at a special meeting passed Resolution No. 06-07-25,  
4 "Approving Amendment #2 to the Sif-Oidak District FY 2007 budget"; and

5 WHEREAS, an amendment was made to increase the minimum wage for the Youth Worker  
6 Positions from \$5.15/hr to \$6.75/hr and decreased the number of work weeks from 6 -  
7 4.5; and

8 WHEREAS, amended the Youth Monitor's wage from \$6.50/hr to \$7.00/hr and decreased the  
9 number of work weeks from 8 - 5; and

10 WHEREAS, increased the number of Youth Workers from 20 to 21; and

11 WHEREAS, the changes does not have a negative impact on the salary totals; and

12 WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee did review the  
13 amendment on June 26, 2007 and recommends approval.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does  
15 hereby approve Amendment #2 to the Sif-Oidak District FY 2007 Budget as presented.

16 BE IT FURTHER RESOLVED that Amendment #2 will be retroactive to June 25, 2007.

17 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
18 Nation's Officials to-wit: the Chairman and any designated Official, are authorized to  
19 execute the budget, provided however, that any amendments affecting the funds or  
20 funding levels of the budget shall be submitted for further prior approval by the  
21 Tohono O'odham Legislative Council.


22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day  
23 of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
24 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section  
25 1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).




